## **EMPLOYEE BENEFITS**



**Interest Free Loans** – Employees are eligible for a \$1,000 interest free loan one time a year.

- \$90 application fee
- No credit required
- 12 month term
- Approval guaranteed



**Discounted Loan Rates**<sup>1</sup> – Employees are eligible for the following loan discounts:

- 0.25% Auto Pay
- 0.50% Direct Deposit
- 0.50% Preferred Partner Employee
- This is potentially a total of 1.25% off their qualified rate



**Special Deposit Rates**<sup>2</sup> – Employees are eligible for special deposit rates on Share Certificates.

• The employee will receive 0.25% above Certificate rate.



**Preferred Partner Advantage**<sup>3</sup> – Get \$50 deposited into the employee's account as a thank you from Valley Credit Union, PLUS, 1% cash back to the employee on their initial deposit.



<u>**Training/Educational Scholarships**</u> – \$1,000 scholarships are available to employees who want to advance their career with their current employer.

- The manager must submit the request to Valley explaining the need, Valley would then decide on that application
- The employee must have been employed by company for a minimum of 1 year



Membership Qualifications for the Preferred Partner Program:

- Employee must be currently employed by company. Proof of workplace ID, current paystub, or verification through the company's Human Resource Department required.
- Employee must have their payroll Direct Deposit with Valley.
- · Employees must open a Rewards Checking account with a debit card.
- Only direct employees are eligible for the perks, no other family members.
- Valley will award six scholarships across all our Preferred Partners every calendar year.
