Influenza PCR

PCR testing for Influenza A and B was implemented in November primarily for inpatient testing. Testing is performed on the Cepheid GeneXpert which also performs our molecular MRSA and CDIFF assays. The Cepheid Xpert Flu Assay is a multiplexed real-time RT-PCR assay that differentiates Influenza A, Influenza B and 2009 H1N1.

Specimen Requirement:

A nasopharyngeal swab collected according to our established influenza nasal swab collection procedure.

Nasal aspirate/wash specimens may also be used. Specimens should be placed into Universal Transport Media and transported to the laboratory.

Test Changes

Lipid Panels

The CHOL/HDL Ratio has now been added to all Lipid Panels. The Reference Ranges are:

3.0 or below	Low Risk	
3.1 to 4.4	Average Risk	
4.5 to 5.0	Increased Risk	
5.1 to 6.4	High Risk	
6.5 or greater	Extreme Risk
