2016 Big Sky Medicine Conference



March 17-20, 2016
Yellowstone Conference Center
Big Sky, Montana

Course Description

This conference is designed to provide internists, family physicians and allied health professionals from the primary care setting with the most current information in a range of general clinical review topics. This year's conference will focus on Systems of Healthcare, as well as clinical topics. Updates, case studies, and clinical strategies for patient evaluation/management, with an emphasis on process improvement, will be presented in an informal atmosphere that facilitates audience participation and discussion.

Accreditation

Billings Clinic is affiliated with the University of Washington School of Medicine.

Course Objectives

- Explain the purpose of physician certification and the historical, current, and emerging ABIM Maintenance of Certification (MOC) Requirements.
- Discuss challenges faced by rural health care systems, including provider recruitment and retention, coordination of care, integration of telehealth, and implementation of tools to encourage a learning environment, such peer review and Project ECHO.
- Review the uses of technology in medical education, describe the benefits and drawbacks from an educational and financial point of view, and discuss where and how learners benefit most from use of technology in the clinical setting.

Course Objectives, cont.

- Discuss the state of the literature on burnout in doctors, consider mitigating factors that can be applied individually, and explain resources that can help decrease your (and learner) burnout as caused by practice factors.
- Explain the rationale behind evidence-based perioperative testing, recognize when perioperative testing is NOT indicated (often!), and utilize cases to illustrate these points.
- Utilize the GOLD criteria to formulate a diagnosis and assessment for COPD, outline a management strategy for stable COPD, and discuss COPD hospitalizations and management of exacerbations.
- Discuss assessment and plans for transitions of care and consider how standardization of documentation and discharge summaries can improve transitions of care.
- Describe the primary function of the endocannabinoid system (ECS) and identify potential roles of the ECS in treatment of PTSD.
- Identify three new agents of potential abuse and describe two behaviors that have addiction potential.
- Describe the new reimbursement Medicare options (MIPS/APM) that were authorized by law (MACRA) and examine the effects of the push to "value based care" on clinical practices in the future.
- Summarize the differential diagnosis for common rectal complaints, recognize those rectal complaints that warrant further work-up, and discuss treatment options and when to refer to a general surgeon.
- Recognize an adequate spirometry, correlate spirometry and pulmonary diseases, explain lung volumes and flow / volume curves, and describe field walking testing.
- Evaluate data on number of patients with a hospital admission within two weeks of an outpatient Same Day Care visit; consider patient demographics, comorbidities, and primary care physician assignment; and discuss a predictive model for triaging patients in the Same Day Care setting.
- Identify the importance of teamwork in the clinical environment, practice three team-enhancing tools that could improve your practice, and describe the process for implementing TeamSTEPPS.
