Our new Psychiatric Stabilization Unit exemplifies innovation at work. Emergency rooms across the country are on the frontlines of the mental health crisis. Caring for these patients in a traditional emergency room setting is exceptionally challenging. Our Psychiatric Care Team has passionately sought to provide a better standard of care, spending countless hours researching and conceptualizing a more supportive experience that will lead to better patient outcomes.

Redefining urgent care for psychiatric patients required not only passion and planning, but financial resources to invest in solutions vital to success. An unwavering commitment was needed by all, as real-world business models, integration of information technologies and complex clinical workflows came together to create the first Psychiatric Stabilization Unit in our state.

Making this possible was the shared vision and partnership of our donors, who not only funded the entire construction cost of the unit, but also secured its future through an endowment. The Stabilization Unit is just one step in a multi-pronged, proactive approach our team is leading to improve mental health care in our community, state and region and we are proud to share their important work in this report.

Mental illness is at a crisis point in our country, affecting individuals and families regardless of age, gender, ethnicity, race or economic circumstance. Left untreated, the consequences are profound: damaged relationships, loss of employment, homelessness, incarceration, and suicide. Billings Clinic has thoughtfully allocated resources to develop the most comprehensive psychiatric program in our state. Realizing the *critical* importance of mental health care, we have subsidized these services at a significant loss for decades.

The barriers to mental health care are numerous. One significant factor is the severe shortage of mental health care providers, especially in small isolated communities throughout Montana and Wyoming. In fact, 55 of 56 Montana counties are designated mental health shortage areas. Current traditional approaches to mental health care delivery have helped only a fraction of those in need. To address this critical issue, Billings Clinic desired to find a new paradigm for mental health care delivery. With the passionate leadership of Psychiatric Services Department Chair Eric Arzubi, MD, Billings Clinic's mental health care team has sought innovative solutions to increase access to mental health care. The development of these new programs simply would not have been possible without significant philanthropic support.

Providing mental health care to 37 sites across Montana and Wyoming

Billings Clinic has launched Montana's only Project ECHO hub. Project ECHO (Extension for Community Healthcare Outcomes) is a collaborative model of medical education and care management that empowers clinicians in rural settings to deliver medical care comparable to major health care centers. A multidisciplinary team at the Project ECHO hub (Billings Clinic) holds bi-weekly clinical training and case review sessions for providers at rural 'spoke' sites. Spoke sites share de-identified case profiles on real patients and the challenges they face in daily practice. Together, the two groups review evidence-based strategies that show clinical effectiveness. At present, Billings Clinic hosts five Project ECHO tele-clinics focused on mental health, opioid and general substance use disorders, pediatric mental health, integrated behavioral health, and adverse childhood experiences. Generous grants from the Montana Mental Health Trust, Montana Medicaid, Blue Cross Blue Shield Montana, PacificSource Health Plans, and Wells Fargo Foundation have supported the development and expansion of Project ECHO.

Psychiatric Stabilization Unit Innovating urgent psychiatric care

Breaking the mold of the traditional emergency room approach to caring for patients with urgent mental health needs, our region's first Psychiatric Stabilization Unit allows for the care of up to twelve adults and five children. Initiating therapeutic measures quickly in an environment better suited to meet the needs of patients in psychiatric crisis is key to this novel treatment approach. Designed with an open-concept, nature photography, comfortable seating, and garden views, staff are better able to engage with patients, lessening their feelings of agitation, anxiety and loneliness. For some patients, a higher level of care will be needed; when appropriate, they will be admitted to our psychiatric hospital. For many, a psychiatric crisis can be resolved in hours and, with thoughtful aftercare planning, patients can be empowered to build a healing network that will continue to support them after discharge.

This ground-breaking unit was made possible with the transformational support of the Helmsley Charitable Trust and other significant donations from the Fortin Foundation of Florida, the Charles M. Bair Family Trust and Stillwater Mining Company. Proceeds from the 2017 Classic have been dedicated to building an endowment for the unit's longterm support.

Integrated Behavioral Health Strengthening mental health care in the primary care setting

Collaborative Care, the gold standard for integrated behavioral health, is an exciting new program that helps primary care physicians provide exceptional holistic care for patients. Through this program, licensed clinical social workers are embedded in the primary care practice, readily available for physician or patient consultation. When patients need care for symptoms of anxiety or depression as part of their overall medical needs, a therapist in the medical practice is available to support the patient with appropriate strategies including therapy, psychiatric referrals, and post-appointment contact. Additionally, Billings Clinic psychiatrists offer educational services to primary care physicians on best practices and new developments in behavioral health care. This program is supported through a generous grant from the Montana Healthcare Foundation.

Psychiatric Residency Training Program Combating the severe shortage of psychiatrists in rural states

Billings Clinic is a vocal advocate for establishing a psychiatry residency training program to address the serious shortage of psychiatrists in Montana. A grant from the Montana Healthcare Foundation supported investigating opportunities to develop such a program at Billings Clinic. In addition, The Montana Legislature, realizing graduate medical education is one of the keys to attracting more physicians to Montana, allocated additional resources to support medical residencies across our state.

We are grateful to our philanthropic stakeholders who partner with Billings Clinic to shape the future of mental health care in our region. Our primary focus – delivering hope and healing to thousands of Montanans struggling with mental illness. 




The Bair Legacy

The eldest daughter of legendary business and ranching magnate Charles M. Bair, Marguerite Bair Lamb established a lasting legacy of caring for the lives and health of generations of Montanans in Meagher, Wheatland, and Yellowstone Counties. Upon Marguerite's death, Billings Clinic was fortunate to be included as one of the recipients of her estate through the Charles M. Bair Memorial Trust. Her bequest has touched almost every aspect of Billings Clinic, funding key capital projects and endowments supporting health care excellence across our organization.

Marguerite was the lesser known of the two Bair sisters. Her demure and guiet presence was often overshadowed by the gregarious, out-going nature of her younger sister, Alberta. But they were an inseparable pair, living and traveling together for the duration of their long and adventurous lives. Although Marguerite married later in life, neither sister had children of their own. They spent a great deal of time discussing their estate plans and strong desire to honor their parents' legacy. Upon her death, Alberta established the Charles M. Bair Family Trust. Her legacy also continues to elevate the human condition throughout our region through the Family Trust's support of many nonprofit organizations, including Billings Clinic. Charles, Mary, Marguerite and Alberta, with their intrepid spirits and hearts as large as the big skies of Montana, are a treasured part of Montana's past, and through their far-sighted philanthropy, our future.

In 1963, Dr. John and Rita Heizer left the congestion of Los Angeles for the beauty of Big Sky country and the collegiality of Billings Clinic physicians. Nine years later, John, a thoracic surgeon by training, would lead an exceptional team of pioneering doctors, nurses and technicians in performing the first open-heart bypass procedure in Montana. Dr. Heizer's remarkable achievement was unparalleled for the times. Success was achieved on February 1, 1972, with the first open heart bypass surgery being performed on a man from Miles City. A Lasting Commitment to Rural Montana

Gary, the son of June and Violet Haigh, grew up in Ennis, Montana. After high school, he worked at the Yellowstone Talc Mine as part of their demolition and explosives crew. This is where he got his first taste of emergency medicine, becoming an EMT in 1983. From there Gary's passion grew as he went on to hone his skills becoming a paramedic and EMT trainer. Always wearing a stylish Derby hat, Gary excelled at teaching the practical lifesaving skills of a first responder. Gary realized early on the importance of first responder care in Montana. Approximately 70% of our state's emergency services rely on volunteers, and in the more rural parts of our state, the number is closer to 100%. Education and training is key for these selfless volunteers. Gary worked tirelessly with local and state agencies to ensure pre-hospital care received the support and recognition it desperately needed.

After his death, with the memorial contributions of fellow EMS providers, friends, and co-workers, Gary's family created the Gary Haigh EMS Scholarship Endowment to carry forward his commitment to rural emergency medical care. Through the careful stewardship of his brother John, the endowment has distributed over \$30,000 to rural emergency medical service providers helping to support critical first responder care throughout our state.

Internal Medicine Residency Update Forging a bold future

Responding to a critical shortage of primary care physicians in rural communities, Billings Clinic launched the state's first Internal Medicine Residency Program in 2014. Nationally, less than 20% of medical residents choose internal medicine as a specialty, and only 6% of that number are drawn to practice in a rural community. The Billings Clinic Internal Medicine Residency Program was designed with the goal of developing excellent general internists skilled in providing care to complex medically ill patients in rural settings. In addition to their indepth training, residents experience the deep needs of rural

communities first-hand during month-long rural rotations at partner

sites in Lewistown, MT, and Sheridan, WY.

For the class that will start in July, 2018, the Internal Medicine Residency program received almost 3,000 applications for eight positions. This class will complete the program in 2021. The fact that Billings Clinic sponsors a residency program has resulted in better success in physician recruiting. Although our program is very young, it has already received three commendations from the ACGME, the body that accredits residency program nationally.

Our first class of residents graduated in June of 2017. Of the eight residents completing the program, six selected hospital/clinic locations in rural areas or health care organizations serving as rural referral facilities. The second class of residents will graduate in June 2018. Six residents are scheduled to complete residency, and three have selected Billings Clinic as their first professional practice site. The other three graduates have been accepted to further advanced professional education in prestigious fellowship programs.

This program would not be possible without the generous support of many donors who have provided both direct support and endowment gifts. The Helmsley Charitable Trust supports this transformational initiative by providing funding for costs associated with initiating the residency, as well as the training expenses for residents at our rural partner sites in Lewistown, MT, and Sheridan, WY.

Lung cancer is the leading cause of cancer-related deaths in the United States, causing more deaths than breast, prostate, and colorectal cancers combined. It is estimated that over 80 percent of lung cancers could be cured if detected at an early stage. In 2014, Billings Clinic and the Whedon Cancer Detection Foundation combined resources creating The Partners for Healthy Lungs screening program at Billings Clinic.

The Whedon Cancer Detection Foundation was created by Sheridan, Wyoming, physician Dr. Earl Whedon and his wife, Bessie, after losing their son to cancer. Dr. Whedon was known as a man of vision. In addition to practicing medicine for 52 years, he delved into politics and began the Whedon Oil Company. Proceeds from his ranch, mineral, and other holdings provided the initial funding of the Foundation.

This partnership provides free low-dose CT lung cancer screenings for at-risk people in Wyoming and Montana, with an emphasis on serving rural and Native American populations. Since 2014, 1060 patients have been screened through The Partners for Healthy Lungs program. Billings Clinic cares for patients who meet the established criteria for screening and follow-up of any cancer that is discovered. Additionally, this program provides educational materials focused on lung cancer, screening, and prevention opportunities available in our region.




