Test Updates

Good News! On July 23, 2013, the FDA approved the Hologic Aptima HPV Assay for use on the Hologic GenProbe PANTHER System. We installed our PANTHER in May 2013 and on June 1, moved all NG/CT testing on genital swabs, urines and ThinPrep liquid cytology specimens to that instrument. Moving HPV to the PANTHER will save labor and also expedite testing since the PANTHER is a single fully automated, random access instrument. It is capable of running multiple tests from a single specimen. Hologic's Aptima HPV mRNA based assay is a nucleic acid amplified test that detects 14 highrisk strains of human papillomavirus (HPV) associated with cervical cancer and precancerous lesions. The Aptima HPV Assay has demonstrated

Our current HPV testing includes the Cervista High Risk assay and the reflex 16/18 assay. Both of these are labor intensive assays requiring manual DNA extractions. Initially, it will be the HPV, High Risk assay that moves to the PANTHER. The HPV 16/18 will continue to be performed by the Cervista method until FDA approval of the Aptima HPV 16 18/45 Genotype Assay on the PANTHER. We will soon start the process to implement the Aptima HPV assay. Additional information will follow in the January Communiqué. A Go-Live date for the new assay has not been set.
