Test Updates

CSF Cell Counts

In May 2014 the Siemens AUWI was implemented for automated urinalysis. In February 2016 we added CSF Cell Counts to the AUWI using the Sysmex UF-1000i flow cytometer side of the instrument. This improved both workflow and turn-around-time and also eased the manual workload for the technical staff previously performing all CSF cell counts using a microscope and hemocytometer. In order to process a CSF specimen through the UF1000i flow cytometer of the AUWI we need a minimum of 1 ml of CSF in the appropriate tube. In most instances, this will be CSF tube #4 or the last tube collected. The number of tubes needing a cell count will depend on the type of patient being seen and where. Our current specimen requirements are:

Specimen:

- A. CSF in sterile collection container
 - 1. CSF specimens should be collected into 4 separate allotments with tubes labeled in order of collection.
 - a. Tube 1 saved for possible cell counts to help distinguish a traumatic tap from a subarachnoid hemorrhage
 - b. Tube 2 used for chemistry and immunological studies
 - c. Tube 3 used for microbiology
 - d. Tube 4 used for routine cell counts, differential and cytology
 - 2. Two cell counts will be performed on all ER CSF specimens; Tube #1 and Tube #4 if 4 tubes are received or Tube #1 and the last tube collected for the 2 cell counts when less than 4 tubes are collected.
- B. CSF from shunt sterile urine collection cup
- C. CSF from the NICU will have the testing written on the tubes. Follow the testing instructions as ordered on each tube.

A cytospin preparation will be prepared on all CSF samples and reviewed. If the UF1000i results do not correlate with the stained cytospin slide, a manual CSF Cell Count will be performed. WBCs and RBCs are reported for both methods in cells/mm³. For CSF nucleated cell counts >5 cells/mm³, a differential will be ordered and performed.
